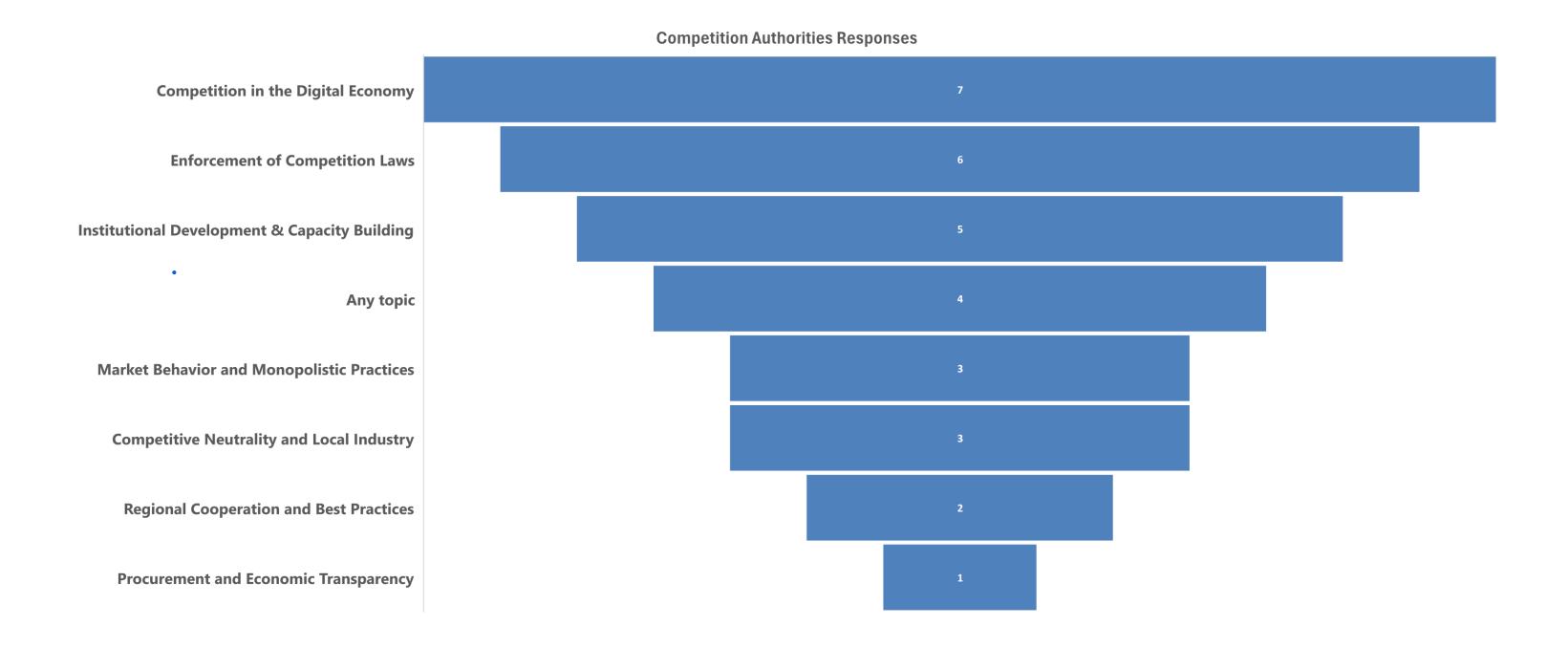






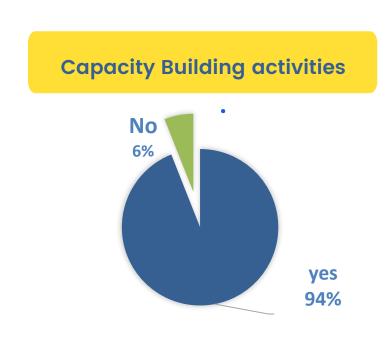


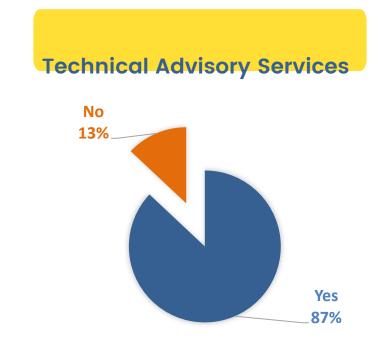
Results of the survey identifying priority topics for the next Arab Competition Forum

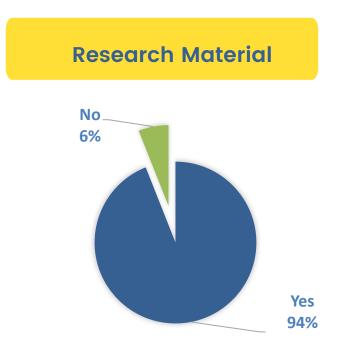


Recommendations of the 5th ACF

- •Capacity Building: Strengthen member states' capacities on competition policy through training on topics such as market studies, economic concentration, government tenders, anti-competitive investigations and SME Support.
- •Technical Advisory Services: Provide advisory services focusing mainly on digitization, competition law enforcement, legal protections, competition guides and mergers & acquisitions.
- •Research and Publications: Publish studies on competition policy trends, including AI applications, innovation, cross-border concentrations and competitive neutrality.

















Recommendations of the 5th ACF (Cont.)

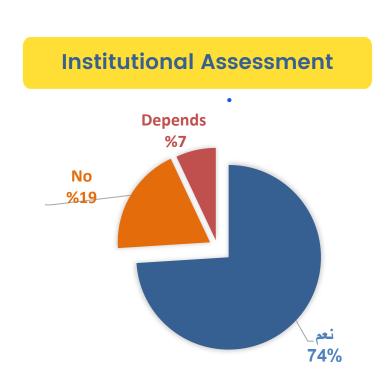


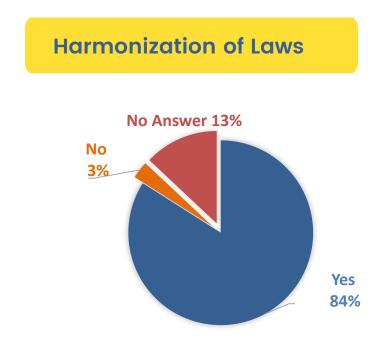


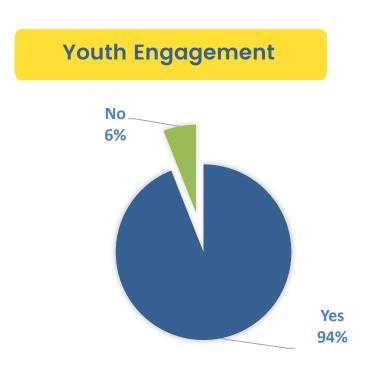




- •Institutional Assessment: Comprehensive assessment by ESCWA of institutional gaps at both the legal and executive levels to ensure Member States' effective compliance with competition regulations.
- •Harmonization of Laws: Work towards unifying competition laws across the Arab region.
- •Youth Engagement: Launch initiatives to raise competition awareness among Arab youth through educational programs, workshops, and campaigns.







Recommendations of the 5th ACF (Cont.)

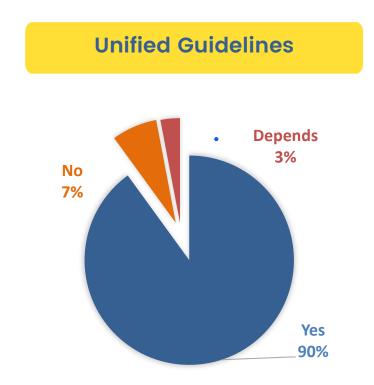


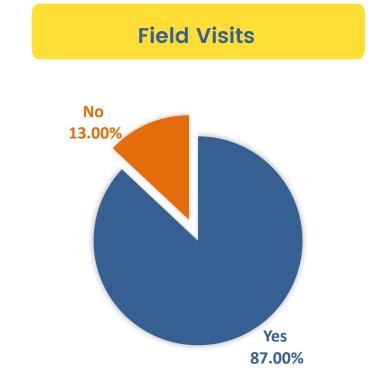


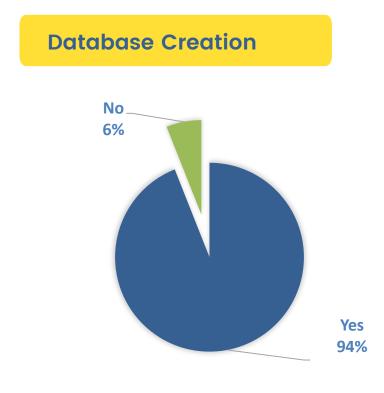




- •Unified Guidelines: Develop region-wide programs to promote competition culture.
- •Field Visits and Exchanges: Facilitate field visits and exchange programs to learn from best practices.
- •Database Creation: Establish a shared platform for decisions and publications from Arab competition authorities.

Hosted by the Iraq Competition Council in May 2025.

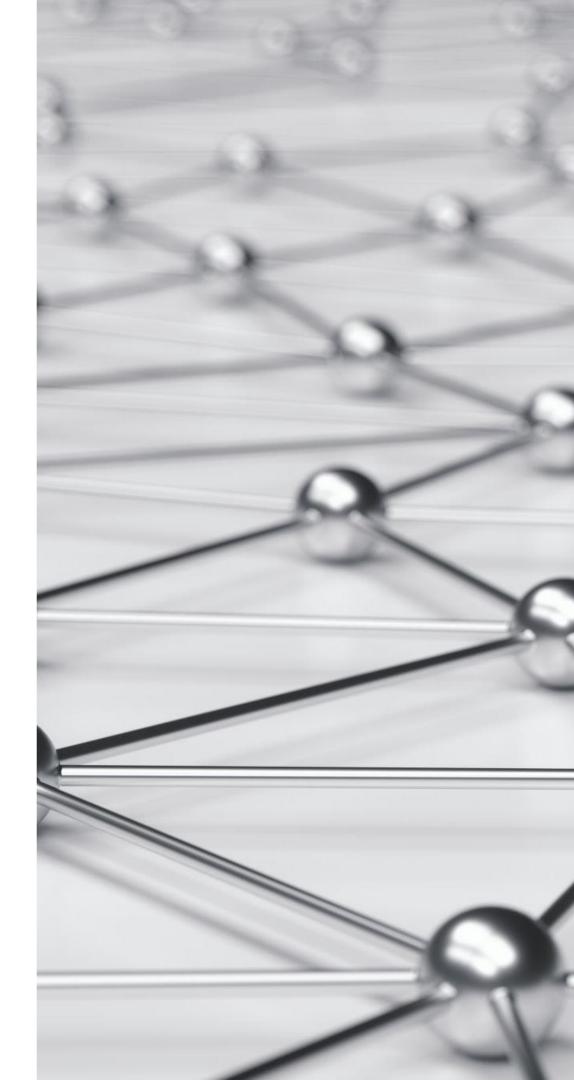
Objectives of the Sixth Arab Competition Forum:
