# PROPOSED PROGRAMME OF WORK FOR THE BIENNIUM 2014-2015 IN THE FIELD OF WATER RESOURCES

#### **Summary**

The proposed programme of work of the Economic and Social Commission for Western Asia (ESCWA) for the biennium 2014-2015 in the field of water resources presents a set of activities and outputs related to the implementation of the expected accomplishments envisaged under subprogramme 1 on integrated management of natural resources for sustainable development, of the strategic framework for the biennium 2014-2015. While subprogramme 1 comprises the work of ESCWA in the fields of energy, water resources and productive sectors, and is implemented by the Sustainable Development and Productivity Division (SDPD) at ESCWA, this document contains the proposed activities in the field of water resources only, which are implemented by the Water Resources Section of SDPD.

The Committee on Water Resources is invited to review the activities listed in the proposed programme of work, and discuss the extent to which they meet the priorities of ESCWA member countries and their relevance to the expected accomplishments in the field of water resources under subprogramme 1. The Committee is also invited to discuss ways to concretely measure the indicators of achievement in order to accurately monitor progress achieved in member countries as a result of implementing the proposed outputs.

#### Introduction

- 1. The activities comprised in the proposed programme of work of the Economic and Social Commission for Western Asia (ESCWA) for the biennium 2014-2015 in the field of water resources were formulated on the basis of subprogramme 1 on integrated management of natural resources for sustainable development, of the strategic framework for the biennium 2014-2015, which was adopted by ESCWA at its twenty-seventh session (Beirut, 7-10 May 2012).
- 2. The Sustainable Development and Productivity Division (SDPD) at ESCWA is responsible for the implementation of subprogramme 1 through its three sections (Energy, Water Resources and Productive Sectors). During the biennium 2014-2015, SDPD will maintain focus on promoting regional and subregional cooperation on sustainable development in the fields of energy, water resources and productive sectors, and assisting member countries in the harmonization of relevant policies and standards. This document presents the proposed outputs to be implemented by the Water Resources Section.
- 3. In preparing those outputs, the secretariat has given due consideration to the following:
- (a) Major challenges facing the Arab region, including issues that have emerged during the implementation of the programme of work for the biennium 2010-2011 and in 2012;
- (b) Progress achieved by member countries in the implementation of global policy on sustainable development, including the outcome document entitled "The future we want", which was adopted at the United Nations Conference on Sustainable Development (Rio+20) held in June 2012, the Johannesburg Plan of Implementation which was adopted at the World Summit on Sustainable Development in September 2002, Agenda 21 which was adopted at the United Nations Conference on Environment and Development in 1992, and resolutions of the United Nations Commission on Sustainable Development (CSD), in particular with regard to the water-energy-food nexus;
- (c) The Arab Ministerial Declaration on Climate Change, which was adopted by the Council of Arab Ministers Responsible for the Environment at its nineteenth session (Cairo, 5-6 December 2007), and in which the ministers affirmed the determination of their Governments to adopt national and regional action plans on climate change issues, with a view to assessing possible impacts and developing mitigation and adaptation programmes, and to include climate change policies in all sectors within national and regional policies for sustainable development;
- (d) General Assembly resolution 63/281 of 3 June 2009 on "Climate change and its possible security implications", and ESCWA resolution 281 (XXV) on "Addressing climate change issues in the Arab region" adopted at its twenty-fifth session (Sana'a, 26-29 May 2008), in which member country representatives requested the secretariat to prepare an assessment of the vulnerability to climate change of economic and social development in the region, with particular emphasis on fresh water resources.
- 4. Driven by those global and regional mandates, ESCWA is exerting extensive efforts to develop an assessment of the impacts of climate change on water resources and socioeconomic vulnerability in the Arab region, and build capacities of member countries on relevant climate change adaptation and mitigation measures. Therefore, additional activities on climate change that are multidisciplinary in nature are expected to be undertaken under subprogramme 1. Resources to support field projects related to the water sector during the bienniums 2012-2013 and 2014-2015 have been secured from the Swedish International Development Cooperation Agency (SIDA), the German Federal Ministry for Economic Cooperation and Development (BMZ) and the United Nations Development Account (DA).

## I. ACTION REQUIRED OF THE COMMITTEE ON WATER RESOURCES

5. The Committee on Water Resources is invited to review the proposed outputs and provide its guidance to the secretariat based on the following two criteria: (a) the extent to which the proposed outputs respond to the needs of intended beneficiaries, namely ministries and authorities in the Arab region in charge of water resources issues; and (b) the extent to which those outputs contribute to the realization of the expected accomplishments of subprogramme 1, while taking into account also the outcome of the deliberations that take place at the present session.

# II. SUBPROGRAMME 1: INTEGRATED MANAGEMENT OF NATURAL RESOURCES FOR SUSTAINABLE DEVELOPMENT

A. OBJECTIVE OF SUBPROGRAMME 1 FOR THE BIENNIUM 2014-2015

6. The objective of subprogramme 1 is to achieve sustainable development in the region through integrated natural resource management. The responsibility for implementing subprogramme 1 lies with the Sustainable Development and Productivity Division at ESCWA.

#### C. STRATEGY

19.32 The interrelated and complex challenges facing the region and current social and political tensions have wide-ranging consequences that require concerted efforts to strengthen the inter-linkages between the economic, social and environmental pillars of sustainable development and to galvanize action at the national and regional levels. The regional challenges include increasing population pressure and the related rise in demand for water and energy services; rising unemployment, particularly among young people; unsustainable production and consumption patterns; the need to ensure water, energy and food security; the disparity between urban and rural development; low agricultural productivity; traffic congestion and unsustainable transport systems; and climate change and its impact on water resources, desertification and land management.

19.33 To enhance the impact of the work of ESCWA and improve its services to the countries of the region, the work under subprogramme 1 will focus on providing support to those countries to address the above-mentioned challenges and to move towards a more sustainable development pathway.

19.34 The subprogramme will undertake or continue to pursue the following actions:

- (a) Advocating and raising awareness of global commitments, particularly the Millennium Development Goals and the outcomes of major United Nations conferences on sustainable development, especially the United Nations Conference on Sustainable Development (Rio+20), and to monitor and support follow-up actions;
- (b) Serving as a forum for promoting policy dialogue on sustainable development issues and priorities for forging regional positions and perspectives based on the exchange of information, lessons learned and best practice;
- (c) Supporting member countries in their efforts to improve the efficient use of renewable and non-renewable water, energy and land resources, including the application of appropriate environment-friendly technologies, and to encourage the integrated management of water, energy and land to achieve sustainable development;
- (d) Facilitating regional cooperation and coordination on water, energy and land as the means to enhance food, water and energy security;
- (e) Contributing to national and regional capacity-building, especially on water, energy (including renewable energy) and agricultural issues;
- (f) Supporting the development of national or regional mechanisms for the integration of the economic, social and environmental pillars of sustainable development;

- (g) Supporting the development of national or regional mechanisms to address climate change impacts;
- (h) Supporting the efforts of member countries to strengthen small and medium-sized enterprises for job creation and economic diversification.
- 19.35 This will be achieved by servicing intergovernmental bodies; conducting high-quality research and analytical work; organizing intergovernmental and expert meetings; providing advisory services; implementing field projects, including extrabudgetary and DA projects; building capacity through workshops and other technical assistance activities; and issuing technical material to raise awareness of key sustainable development issues and challenges targeted for global and regional action in 2014 and 2015.
- 19.36 The work under the subprogramme will strive to maximize synergies through collaboration with United Nations agencies and organizations, including the United Nations Environment Programme (UNEP), the United Nations Industrial Development Organization (UNIDO), the United Nations Educational, Scientific and Cultural Organization (UNESCO), the International Fund for Agricultural Development and the Food and Agriculture Organization of the United Nations (FAO), and through participation in the United Nations inter-agency coordination mechanisms on water resources and energy (UN-Water and UN-Energy), and the Regional Coordination Mechanism (RCM). It will continue to cooperate with the League of Arab States and its associated bodies, particularly the Council of Arab Ministers Responsible for the Environment (CAMRE), the Arab Ministerial Council for Water (AMCW) and the Arab Ministerial Council for Electricity, in addition to other regional mechanisms for coordination on sustainable development.

#### D. EXTERNAL FACTORS

Subprogramme 1 will achieve its expected accomplishments provided that: (a) member countries remain committed to giving due priority to sustainable development issues and adopt appropriate measures; (b) political stability is improved and member countries are willing to cooperate on sustainable development issues; and (c) there are no significant shortfall in extrabudgetary resources.

#### E. OUTPUTS

The Sustainable Development and Productivity Division which comprises three sections (Energy, Water Resources and Productive Sectors) is responsible for the implementation of expected accomplishments under subprogramme 1. This document, however, presents only the activities falling under the responsibility of the Water Resources Section. During the biennium 2014-2015, the following outputs connected to each accomplishment are expected to be implemented by the Water Resources Section:

# RESOLUTIONS OF THE ARAB MINISTERIAL WATER COUNCIL CONCERNING THE WORK OF ESCWA

Res 18 – Regular session 2 2 July 2010	"Calls upon ESCWA, and in coordination with ACWUA, CEDARE, the World Health Organizations (WHO), AWC and RAED, to prepare a unified template of indicators (basic and additional) and standards for the implementation of the Millennium Development Goals related to water supply and sanitation, and to forward it to the Council's Technical Scientific Advisory Committee no later than 30 October 2010".
Res 20 – Regular session 2 2 July 2010	"Invites the Center of Water Studies and Arab Water Security and ESCWA, in coordination with the Arab Center for the Studies of Arid Zones and Dry Lands (ACSAD) and Stockholm International Water Institute (SIWI), to develop a legal framework for shared water resources within the Arab region to be discussed at the fourth meeting of the Council's Technical Scientific Advisory Committee".
Res 35 – Regular Session 3 15 June 2011	"Invites the United Nations Economic and Social Commission for Western Asia (ESCWA), Arab Countries Water Utilities Association (ACWUA), Centre for Environment and Development in the Arab Region and Europe (CEDARE), Arab Water Council (AWC) and Arab Network for Environment and Development (RAED), to contact regional and international funding agencies in order to secure funding for the implementation of activities related to the provision of an information system and the building capacity of national focal points and other activities related to the preparation of the first report on the progress made towards implementing the MDG on water supply and sanitation in the Arab region and that is based on the indicators and standards mentioned in the adopted unified template".
