ORGANIZATION OF WORK

Note by the Executive Secretary

The present document on the organization of the work of the sixteenth session of the Economic and Social Commission for Western Asia should be read in conjunction with the provisional agenda for the session, which was issued as document E/ESCWA/16/L.1/Rev.2.

The proposed organization of work for the session, should it be endorsed by the ministerial-level session of the Commission, is intended to achieve a greater degree of efficiency and coordination between the work of the ministerial-level session and that of the seventh session of the Technical Committee; at the same time, the proposed organization of work bears in mind the relevant resolutions of the Economic and Social Council and of the Commission and the rules of procedure of the Commission.

It may be recalled that the Economic and Social Council, in its resolution 1984/80 of 27 July 1984,

- "2. <u>Decide[d]</u> to designate the Standing Committee for the Programme of the Economic Commission for Western Asia as the Technical Committee and to add to its terms of reference, set out in paragraph 5 of Commission resolution 114(IX) of 12 May 1982, the consideration of the items of the provisional agenda for the annual session of the Commission, in preparation for the Commission's meeting at the ministerial level;
- "3. <u>Decide[d] also</u> that the Technical Committee should meet for a four-day period immediately prior to a two-day meeting of the Economic Commission for Western Asia at the ministerial level."

However, as an exception to the above, the secretariat wishes to propose to the ministerial-level session of the Commission that the Technical Committee start its meetings at 1530 hours of the first day of the formal opening of the Commission's sixteenth session, hold subsequent meetings that at times take place simultaneously with the plenary meetings of the ministerial-level session and conclude its work by Wednesday, 2 September, noon, in time for the preparation and submission of its report for consideration and adoption by the ministerial-level session of the Commission.

It is further proposed that sub-items 5(a), 5(b) (viii) and 5(b) (ix) and items 6 and 7 of the provisional agenda be allocated for consideration by the Technical Committee.

Regarding the officers of the Technical Committee, it is proposed that one of the Vice-Chairmen elected by the Commission at the outset of the session serve as Chairman of the Technical Committee, which at its first session shall elect its Rapporteur.

On the basis of the aforementioned, the following organization of work is being proposed, with the understanding that this timetable should be considered tentative. Should the ministerial-level session of the Commission or the Technical Committee complete consideration of an item before an indicated date or time, it may move immediately to the next item on its work schedule.
