Proposed amendments to the programme of work for the biennium 2016-2017

Summary

This document presents amendments to the programme of work of the Economic and Social Commission for Western Asia (ESCWA) for the biennium 2016-2017, proposed by the ESCWA secretariat. These amendments are based on the new mandates that emanated from the seventieth session of the United Nations General Assembly, and on the global and regional needs and challenges that have emerged since the adoption by the Commission of its programme of work for the biennium 2016-2017 at the first Executive Committee meeting (Amman, June 2015).

The Commission is invited to consider the proposed amendments with a view to endorsing them for incorporation into the programme of work for the biennium 2016-2017.

Introduction

1. This document presents amendments proposed by the secretariat of the Economic and Social Commission for Western Asia (ESCWA) to the programme of work for the biennium 2016-2017. These amendments are based on the new mandates that emanated from the seventieth session of the United Nations General Assembly, and on the global and regional needs and challenges that have emerged since the adoption by the Commission of its programme of work for the biennium 2016-2017 at the first Executive Committee meeting (Amman, June 2015).
2. The secretariat is proposing these changes with the aim of aligning the programme of work for the biennium 2016-2017 with the strategic pillars determined for the biennium 2018-2019, in order to ensure programme continuity. The changes are also intended to make an optimal use of the resources available while enhancing the quality, relevance and impact of the services provided to member States.
3. The Commission is invited to consider the proposed amendments with a view to endorsing them for incorporation into the programme of work for the biennium 2016-2017.
