INTRODUCTION

The revised programme of work for the biennium 1994-1995 has been streamlined into thematic subprogrammes in an attempt to create a critical mass for ESCWA activities, which is one of the primary concerns that underline the restructuring of ESCWA programmes.

Hence, in the initial programme of work, activities which addressed interrelated issues may have been dispersed among the 15 substantive subprogrammes carried out by ESCWA. In the revised submission, the ESCWA secretariat has endeavoured to regroup activities under the following five thematic subprogrammes, as follows.

Thematic Subprogramme 1. Management of Natural Resources and Environment

Under this subprogramme fall the following activities:

- (a) Most of those of the energy, water and environment activities;
- (b) Some of the agricultural activities related to the management of land and environment;
- (c) Some of the human settlements activities related to energy and environment;
 - (d) Some of the industry activities related to environment and energy;
 - (e) Statistics on energy and environment.

Thematic Subprogramme 2. Improvement of the Quality of Life

Under this subprogramme fall the following activities:

- (a) All social development, population, women, and human settlements activities;
 - (b) Some of the agricultural activities related to rural development;
- (c) Some of the industry activities related to small-scale industries and participation of women in manufacturing industries, and employment opportunities through small-scale industries;
- (d) Statistics on population, labour, women, human development, and social development.

Thematic Subprogramme 3. Economic Development and Cooperation

Under this subprogramme fall the following activities:

- (a) All development issues, and trade, public administration, finance and transnational corporations activities;
 - (b) Most of the activities on industry, technology and transport;

- (c) Most of the activities on agriculture;
- (d) Statistics on national accounts, finance and industry.

Thematic Subprogramme 4. Regional Development and Global Changes

Under this subprogramme fall the following activities:

All those dealing with the impact of the single European market, the General Agreement on Tariffs and Trade (GATT), privatization, some of the transnational corporations and relevant global events as well as some activities relating to the quality of life (the social impact of structural adjustments).

Thematic Subprogramme 5. Special Issues

Under this subprogramme fall the following activities:

All those dealing with Palestine, Yemen as a least developed country (LDC), countries affected by wars, the impact of the peace settlement on the region and other relevant emerging events.

The main objective of this revision was to promote a multidisciplinary approach to the planning and implementation of the majority of activities envisaged by ESCWA, to rationalize resources, and to create greater impact through the consolidation of the multiple facets of numerous activities.

The five thematic subprogrammes will be implemented through specialized task forces/working groups by six substantive ESCWA organizational units (divisions), namely:

- (a) The Economic Development Issues and Policy Analysis Division;
- (b) The Social Development Issues and Policy Analysis Division;
- (c) The Energy, Natural Resources and Environment Division;
- (d) The Industry, Technology and Transport Division;
- (e) The Joint FAO/ESCWA Food and Agriculture Division;
- (f) The Statistics and Information Services and Support Division.

The division which is most relevant to a specific core activity will act as the coordinator of the relevant task force or working group.

The area of statistics is considered cross-thematic; thus it will service the statistical needs of all the relevant subprogrammes. The substantive preparations for databases (selection of indicators) will be initiated jointly by the Statistics and Information Services Support Division and by the concerned substantive divisions, with the collection and compilation carried out by the Statistics Division. The analysis of the data will naturally take

place in the substantive divisions. This division of labour will take place in accordance with a work plan adopted by the divisions concerned.

It should be noted that, contrary to previous practice, whereby human and financial resources were allocated to subprogrammes, resources will henceforth be pooled from various substantive subprogrammes to implement activities that fall under the five core themes that constitute the framework for all ESCWA activities.

However, the programme of work for the biennium 1994-1995 does not yet reflect the full thrust of the restructuring of ESCWA programmes in terms of the creation of a fully consolidated critical mass of activities. Naturally, programme of work still contains former activities classification under the designated core themes may seem to be somewhat redundant. This is mainly attributable to the fact that some activities initiated in the programme of work for the biennium 1992-1993 need to be completed in the programme of work for the biennium 1994-1995. Thus previous commitments have been made to implement a number of such activities. The current revised programme of work should be viewed as a transitional work programme with vestiges and flaws of the former programming process. However, it is hoped that this transition will lead to a fully coordinated programme of work for the biennium 1996-1997 which will be conceived along the designated thematic lines.

Needless to say, this revised programme of work is based on the second revision of the medium-term plan for the period 1992-1997, which was also reorganized in line with the thematic subprogrammes outlined herein.

THEMATIC SUBPROGRAMME 1. MANAGEMENT OF NATURAL RESOURCES AND ENVIRONMENT

The activities to be carried under this subprogramme will focus on promoting regional and subregional cooperation in the development of natural resources. Special emphasis will be placed on establishing statistical databases on energy and environment, assisting in the formulation of policies and measures for the proper management of natural resources (land, water and energy), promoting the application of environmentally sound technologies for the development of water and energy resources in the region and enhancing regional capacities in environment impact assessment.

1. <u>International cooperation</u>

External relations

Activities will be coordinated with the secretariat of the League of Arab States and its affiliated organizations such as the Council of Arab Ministers for Environment, the Arab Organization for Agricultural Development (AOAD); and the Arab Centre for the Study of Arid Zones and Dry Lands (ACSAD). Close cooperation and regular contacts will also be maintained with regional and international entities such as the World Bank, the Organization of the Islamic Conference, the International Energy Agency, the World Energy Council, the Liquefied Petroleum Gas Forum, the Organization of Arab Petroleum Exporting Countries (OAPEC), the Organization of Petroleum Exporting Countries (OPEC), the International Institute for System Analysis, the Centre for Environment and Development in the Arab Region and Europe, the Joint Committee on Environment and Development in the Arab Region and other regional and international organizations concerned with the implementation of Agenda 21.

of the United Nations (FAO), and its affiliated organizations, especially the International Centre for Agricultural Research in the Dry Areas (ICARDA), the United Nations University, and United Nations Commission on Sustainable Development, the Committee on Natural Resources and Renewable Sources of Energy, the ACC Subcommittee on Water Resources, and other regional and international organizations concerned with regional and global environmental issues and the implementation of Agenda 21.

THEMATIC SUBPROGRAMME 2. IMPROVEMENT OF THE QUALITY OF LIFE

The interdisciplinary and intersectoral activities to be carried under this subprogramme will focus on different aspects that would lead to the improvement of the quality of life of the people of the region. Special emphasis will be placed on the development of statistical databases on population, women, labour, human development and social conditions. addition, textual databases will be introduced for the first time in order to monitor policies and measures related to population, human development, social progress, women and human settlements. This subprogramme will also address for the first time issues related to human development and the implementation of its concepts in national development. It will focus on preparation for the International Year of the Family (1994), the World Summit for Social Development (1995), the Fourth World Conference for Women (1995) and the United Nations Conference on Human Settlements (Habitat II) (1996). subprogramme will also focus on the three core themes of the World Summit for Social Development: alleviation and reduction of poverty, expansion of productive employment and enhancement of social integration in addition to the fourth core theme adopted for the ESCWA region, the cultural dimension of development as well as the core themes of Habitat II, namely, urbanization and adequate shelter. Community development, with particular emphasis on rural development, will be addressed through research and operational activities. Finally, dissemination of information to end-users on trends, data and indicators to monitor improvements in the quality of life will be a continuous activity in this subprogramme.

THEMATIC SUBPROGRAMME 3. ECONOMIC DEVELOPMENT AND COOPERATION

The activities undertaken under this subprogramme will cover mainly the issues of economic development and regional economic cooperation, with special emphasis on: the annual Survey of Economic and Social Developments in the ESCWA Region; review of developments in the external trade and payments situation, monetary, fiscal and financial sectors and foreign direct investment; review of recent development in other economic sectors (industry, agriculture, transport); statistical data of interest to the region including statistical abstracts, external trade, national accounts, and financial,

industrial and transport statistics; review of policies and measures in different economic sectors and the possibilities of coordination at the regional level; assisting in the promotion of large ongoing and planned regional projects, particularly in areas of interconnection of electrical power networks at the regional and interregional levels; and interregional coordination of multimodal transport.

1. <u>International</u> cooperation

External relations

Liaison and cooperation will be maintained with governmental intergovernmental organizations, including the League of Arab States, relevant affiliated organizations, especially AOAD, ACSAD, the Arab Industrial Development and Mining Organization (AIDMO), the Arab Institute for Training Research Statistics, in and the Standing Technical Committee on Statistics. Activities will also be coordinated with regional international organization such as the International Centre for Agricultural Research in the Dry Areas (ICARDA), the Organization of the Islamic Conference, especially the Islamic Foundation for Science, Technology and Development (IFSTAD) and the Islamic Development Bank; the Arab Federation for Food Industries; the Arab Union of Pharmaceutical Manufacturers and Medical Appliance Manufacturers; the World Bank; OPEC; OAPEC; CEDARE; ITU; the Council for Arab Economic Cooperation and its Statistical Committee; AFESD; the International Statistical Institute; as well as national and regional business organizations, dealing with issues relating to transnational corporations and foreign direct investment, including relevant issues stemming from the implementation of Agenda 21.

THEMATIC SUBPROGRAMME 4. REGIONAL DEVELOPMENT AND GLOBAL CHANGES

The activities undertaken under this subprogramme will focus on issues related to global changes and their implications for the social and economic conditions in the ESCWA region. Global changes may include the establishment of the International Trade Organization (ITO), the GATT agreement and the emerging economic blocs, such as the single European market. Consideration will be given to the impact of economic reform policies, including structural adjustment and privatization and the new role of transnational corporations with regard to social and economic conditions in the region.

THEMATIC SUBPROGRAMME 5. SPECIAL ISSUES

This subprogramme will undertake studies and provide technical assistance for the least developed country in the region and the Palestinian people in the occupied Palestinian territories. It will analyse the implications of the ongoing peace process for regional cooperation and development. It will also deal with issues related to the social and economic rehabilitation and reconstruction of war-torn areas.
