# REPORT OF THE EXECUTIVE SECRETARY ON THE ACTIVITIES OF THE COMMISSION

PROGRESS MADE IN THE IMPLEMENTATION OF THE PROGRAMME OF WORK FOR THE BIENNIUM 1992-1993

Technical cooperation activities

The Economic and Social Commission for Western Asia (ESCWA) has continued to undertake technical cooperation activities in the region through the provision of short-term regional advisory services and the monitoring and substantive support of technical assistance projects which the Commission undertakes in its capacity as an executing or associate agency.

# A. Regional advisory services (ESCWA)

Within the framework of the ESCWA regular programme of regional advisory services for the period 1992-1993, assistance to member States was rendered in the following main areas: data processing, energy, environment, human resource development, development planning and policy, promotion and industrial management, national accounts and economic statistics, science and technology, transport and communications, water resource development and social statistics.

The advisory services provided during the above-mentioned period are summarized in the following paragraphs.

- 1. In the area of <u>data processing</u>, assistance and/or advisory services were provided to the following countries in the areas specified:
- (a) <u>Bahrain</u>. Review of building data in the 1991 census, provision of advisory services on the use of the personal computer in deriving planning and population indicators, with special emphasis on the introduction of the building data system in the Department of Physical Planning, and presentation of proposals concerning its future development strategy so that it includes both appropriate equipment for the development plan and training in the operation and maintenance of the system;
- (b) Egypt. (i) Preparation of a project document on capacity-strengthening in the field of informatics jointly by ESCWA and the Institute of Statistical Studies and Research/Cairo University, the National Centre for Social and Criminological Research and the Central Agency for Public Mobilization and Statistics; and (ii) preparation of a country household-survey project;
  - (c) <u>Jordan</u>. Data processing for the Household Income and Expenditure Survey;
- (d) Oman. Preparation of a workshop on data processing and social household surveys through the establishment of the methodological framework for the workshop's activities and a suitable approach for dealing with its training component in the Ministry of Social Affairs and Labour;
- (e) <u>Palestine</u>. (i) Offering of opinions and suggestions on strengthening its statistical organization and providing social and economic data and indicators for the purposes of Palestinian national development in the self-rule areas and the occupied Palestinian territories; and (ii) advisory services on preparations for constructing integrated economic and social statistical data-processing frameworks by preparing for censuses on buildings, housing, installations and agricultural households in Palestinian camps in the Syrian Arab Republic;
- (f) <u>Qatar</u>. (i) Strengthening of statistical activity and computer and software technology at the University of Qatar and in its research centres; and (ii) establishment of an information centre in the secretariat of the Supreme Council for Planning;
- (g) <u>Saudi Arabia</u>. (i) Preparation of a study on the processing of transport data and the assessment of their accuracy as well as the definition of the related specifications for computers and for existing software that might be used for storing and analysing the data of the Ministry of

Communications; (ii) development of statistical data processing; (iii) preparation of a number of studies on statistics; (iv) unification of production-unit standards for the various product coding systems; (v) assessment of the computer operations of the Industrial Affairs Agency of the Ministry of Industry and Electricity;

- (h) <u>United Arab Emirates</u>. Support to and strengthening of statistical work in the Economic Department (Sharjah Emirate);
- (i) Yemen. (i) Processing of data from the Family Budget Survey, offering of opinions on and publication of the results of the Labour Force Survey and expression of opinions on the question of whether data processing should or should not be central; and (ii) processing of data from the general census of population and housing to be conducted in 1994, for the Central Statistics Office.

- (a) Participation in the seventeenth international conference on statistics, computer science and computer applications in the scientific, social and demographic fields, organized in Cairo by Helwan University;
- (b) Participation in the Regional Working Group for Users and Producers of Maternal and Child Health Information for Policy Formulation and Programming, organized in Cairo by the Pan Arab Project for Child Development;
- (c) Assistance and participation in the organization of a Seminar on Household Surveys for Heads of Statistical Organizations and Senior Statisticians in the ESCWA Region, held in Cairo at the headquarters of the Central Agency for Public Mobilisation and Statistics (Egypt);
