Organization of work

Note by the secretariat

1. The secretariat has prepared the proposed organization of work for the thirtieth session of the Economic and Social Commission for Western Asia (ESCWA) to facilitate the consideration of the agenda items within time limitations. The Commission will be presented with the proposed organization of work contained in the present document and shall adopt it in that or an amended form.

2. The senior officials segment will start with an inaugural meeting at 10 a.m. on Monday, 25 June 2018, and resume at 10 a.m. on Tuesday, 26 June 2018, according to the annexed organization of work. The senior officials segment will end at 6 p.m. on Tuesday, 26 June 2018 upon agreement by the participants on the recommendations and resolutions to be submitted for adoption at the ministerial segment.

3. Each presentation made by the secretariat will last for 10-15 minutes and the related discussion for 20-45 minutes. Should the discussion of one item be completed before the specified time, the meeting will move on to the next item.

4. The ministerial segment of the session will open at 9.30 a.m. on Wednesday, 27 June 2018, with a debate on its main theme "Technology for sustainable development in the Arab region". Three round-table discussions will be held, two on Wednesday and one on Thursday, 28 June 2018. The session will conclude at 1.30 p.m. on Thursday, with the adoption of the outcome document and the report of the Commission on its thirtieth session, which contains the recommendations and resolutions.

5. A series of events will be organized on the sidelines of the thirtieth session of the Commission, at 4 p.m. on Wednesday, 27 June 2018, and at 9 a.m. on Thursday, 28 June 2018, at the United Nations House.
