PROPOSED PROGRAMME CHANGES FOR THE BIENNIUM 2006-2007

Summary

The Economic and Social Commission for Western Asia (ESCWA) has reviewed some of the planned outputs in the programme of work for the biennium 2006-2007 and proposes certain modifications aimed at realigning the programme in the light of the 2005 World Summit Outcome, the outcome of the second phase of the World Summit on the Information Society (WSIS), the resolutions adopted by the General Assembly at its 60th session and the review of mandates requested by the States Members of the United Nations.

Additionally, the proposed modifications incorporate the recommendations of the review of the clusters of United Nations entities in the economic and social sphere in order to increase synergies through synchronization and coherence of outputs, and to avoid possible duplication. The information set forth in this report is presented in a table format to facilitate the review of the proposed changes.

The Commission is invited to review and approve the proposed changes.
