Introduction

1. This document presents proposed amendments to the work programme for 2010-2011. These changes are based on the new mandates that emanated from the sixty-fourth session of the General Assembly and from the global and regional needs and challenges that have emerged since the Commission adopted the draft programme of work for 2010-2011 at its twenty-fifth session. The major changes result from the comprehensive proposal of the Secretary-General to the resumed sixty-second session of the General Assembly, which aims to improve the effective and efficient delivery of the mandates of the development-related activities of the United Nations Secretariat, including those of the Economic and Social Commission for Western Asia (ESCWA).
2. The Commission is invited to consider the proposed changes, the background to which is explained in part I, namely, the proposals of the secretariat for changes, with a view to endorsing them for incorporation into the programme of work for the biennium 2010-2011.

I. AMENDMENTS PROPOSED BY THE SECRETARIAT

3. The proposed amendments are intended to make optimal use of the resources available to the secretariat, while further enhancing the quality and relevance of priority services provided in implementing the 2010-2011 work programme.
4. The decision of the Commission on the change in frequency of intergovernmental sessions may also have further programmatic and financial implications, in which case the Commission will be advised of this by the secretariat at the current session.
