Activities of the Technical Advisory Group on Demographic and Social Statistics

Note by the ESCWA secretariat

The secretariat of the Economic and Social Commission for Western Asia is referring to the Statistical Committee the report of the Technical Advisory Group on Demographic and Social Statistics on its fifth and sixth meetings, held on 7 and 8 March 2023 and on 3 and 4 July 2024, respectively.

The two meetings aimed to discuss the importance of providing and completing statistical data within the framework of the "project for the modernization of social statistics in the Arab region", and addressed related topics such as the future of population censuses, civil registration and vital statistics, labour and refugee statistics, and statistical work in times of crisis.

The Statistical Committee is invited to take note of the present report and to discuss and adopt the recommendations therein.

Introduction

- 1. At its eleventh session, held in Amman on 4 and 5 February 2015, the Statistical Committee of the Economic and Social Commission for Western Asia (ESCWA) adopted a recommendation to establish two advisory groups on economic and social statistics. Pursuant to that recommendation, the ESCWA secretariat established the Technical Advisory Group on Demographic and Social Statistics, which held its first meeting in Tunisia, on 17 and 18 October 2016.
- 2. The present report provides the results of the two meetings convened by the Technical Advisory Group on Demographic and Social Statistics since the fifteenth session of the Statistical Committee (Beirut, 16–17 November 2022), i.e. the fifth meeting held in Beirut and online on 7 and 8 March 2023, and the sixth meeting, held online on 3 and 4 July 2024, in cooperation with the League of Arab States.
- 3. The fifth meeting aimed to review and discuss the ESCWA project on "Supporting the promotion and modernization of demographic and social statistics in Arab countries", present the available data for core demographic and social indicators in the Arab countries, discuss the ESCWA electronic questionnaire on these indicators, propose solutions to bridge the data gap, discuss the results of the questionnaire on the availability and sources of labour force data, including surveys and/or relevant records, determine the coverage of data collection of core indicators and ways to disseminate them, and discuss national good practices and existing challenges. During the meeting, a summary of the ESCWA initiative on the classification of social classes in the Arab region was presented, in particular the conceptualization and measurement of the middle class. The meeting also included a review of the regional strategic framework for civil registration and vital statistics, and called for the formulation and development of national strategies for strengthening civil registration and vital statistics.
- 4. The sixth meeting reviewed the core list of demographic and social indicators including those related to sustainable development indicators in Arab countries, discussed tools for collecting data for those indicators and formulated proposed solutions to bridge the data gap. Participants tackled the role of international organizations in providing statistical data, discussed an overview of migration statistics and reviewed developments in censuses, civil registration, vital statistics and statistical surveys, including in countries in difficulty.

I. Outcomes and recommendations

A. Fifth meeting (Beirut and online, 7 and 8 March 2023)

- 5. Participants in the fifth meeting of the Technical Advisory Group on Demographic and Social Statistics agreed on a set of outcomes. They issued the following recommendations on the expected activities of national statistical offices and ESCWA.
 - 1. Recommendations to national statistical offices
- (a) Intensify cooperation and coordination between national statistical offices and data producers within the national statistical system, and relevant regional and international institutions to complete the necessary data series and calculate estimates (in the absence of data);
- (b) Welcome ESCWA estimates and calculations of missing data to fill gaps in the data time series of some indicators, with the need to consult with statistical offices, and present the methodologies used to estimate data wherever they are received and ensure their adoption by statistical offices;
- (c) Welcome the use of a special electronic platform to complete the ESCWA questionnaire for the periodic collection and exchange of statistical data online from countries and national statistical offices to incorporate such data in ESCWA databases and disseminate them;

- (d) Eliminate 36 indicators that do not respond to national statistical offices' continuous updating needs, stressing that their removal from the list does not in any way negate their importance and the need to provide them within the national statistical system, and highlighting the importance of ESCWA support in working on them;
- (e) Attach the utmost importance to providing ESCWA with the required data for the agreed core list of indicators, through the approved mechanism and through statistical offices in accordance with national procedures;
- (f) Ensure that indicators cover all resident populations, including refugees and migrants, and disaggregate data, where possible, to obtain an accurate description of the entire population, by gender, age, geographical location, disability status, income, etc.;
- (g) Intensify efforts to integrate and use international standard definitions with a view to producing high-quality comparable indicators;
- (h) Work on the formulation of national action plans using the ESCWA regional strategic framework for civil registration and vital statistics (2021–2025) to achieve progress in this area;
- (i) Benefit from the ESCWA study on measuring the middle class using labour force surveys and other data sources, and examine technical needs for statistics in this area;
- (j) Continue to encourage the exchange of expertise and experiences among countries in the production of demographic and social indicators.

2. Recommendations to the ESCWA secretariat

- (a) Send a copy of the amended electronic questionnaire to the members of the Committee for follow-up with the concerned stakeholders in statistical offices and with the components of the national statistical system to ensure that the questionnaire is completed within the specified time period;
- (b) Strengthen cooperation and coordination with specialized agencies and international and regional organizations to consolidate efforts, reduce duplication of activities and validate work methodologies, where applicable;
- (c) Organize trainings and workshops for national statistical capacity development as requested by Arab countries, including in areas of population projections and estimates at the local level, particularly in countries facing crises that are not conducive to the implementation of official statistical activities, and provide capacity-building in the area of middle-class measurement;
- (d) Consider the possibility of preparing a study on national good practices and challenges related to the provision of labour force statistics in Arab countries;
- (e) In addition to the official correspondence, consider the possibility of engaging representatives of member States of the Technical Advisory Group on Demographic and Social Statistics in updating the demographic and social data and statistics that statistical offices are required to provide to ESCWA;
- (f) Adopt the regional strategic framework for civil registration and vital statistics (2021–2025) and follow up on national progress in this regard, including assisting in the formulation of national or subregional action plans, discussing difficulties and obstacles facing stakeholders and ways to overcome them, and identifying ways forward.

B. Sixth meeting (online, 3 and 4 July 2024)

6. Participants in the sixth meeting of the Technical Advisory Group on Demographic and Social Statistics agreed on a set of outcomes. They issued the following recommendations on the expected activities of national statistical offices and ESCWA.

1. Recommendations to national statistical offices

- (a) Intensify cooperation and coordination between statistical offices and data producers within the national statistical system, and relevant regional and international institutions to complete the necessary data series and calculate estimates by national statistical offices in coordination with specialized international organizations involved in calculating indicators, and produce data according to the agreed and approved methodology (in the absence of data);
- (b) Continue to update data on the special electronic platform to complete the ESCWA questionnaire for the periodic collection and exchange of statistical data online from countries and national statistical offices to incorporate such data in ESCWA databases and disseminate them;
- (c) Attach the utmost importance to providing ESCWA with the required data for the agreed core list of indicators, through the approved mechanism and through statistical offices in accordance with national procedures;
- (d) Ensure that indicators cover all resident populations, including refugees and migrants by nationality, and disaggregate data, where possible, to obtain an accurate description of the entire population, by gender, age, geographical location, disability status and income;
- (e) Intensify efforts to integrate and use international standard definitions with a view to producing high-quality comparable indicators;
- (f) Continue the formulation of national action plans using the ESCWA regional strategic framework for civil registration and vital statistics (2021–2025) to achieve progress in this area and build on the framework until 2030;
- (g) Consolidate and coordinate efforts in the development of statistical capacities for the production of demographic and social indicators;
- (h) Continue to conduct and document censuses, exchange expertise, participate in the proposed working groups for the implementation of the 2030 census round and present updates on census implementation methods;
- (i) Intensify joint statistical work between countries facing crises, promote the exchange of good practices between them, and provide them with advice and technical support.

2. Recommendations to the ESCWA secretariat

- (a) Continue to coordinate regional and national efforts to collect data from questionnaires, provide support to reduce the data gap upon request, and take advantage of global events to update and partially disseminate data through regional press releases;
- (b) Strengthen cooperation and coordination with the League of Arab States, specialized agencies and international and regional organizations to consolidate efforts and reduce duplication of activities, develop statistical capacity-development programmes that include training programmes, workshops and technical support activities, and validate work methodologies, where applicable;
- (c) Continue to organize trainings and workshops for national statistical capacity development, as requested by Arab countries in various areas, including population projections and estimates, the use of administrative records for statistical purposes, and income and expenditure at the local level, especially in countries facing crises that hinder the implementation of official statistical activities;
- (d) Extend the regional strategic framework for civil registration and vital statistics for Arab countries until 2030 in line with the 2030 Agenda for Sustainable Development, continue to implement the framework guidelines and assess progress, and strengthen the coordination of the regional working group for civil registration;
- (e) Adopt the recommendations emanating from the regional workshop on the mid-term review of the regional strategic framework for civil registration and vital statistics (2021–2025);

- (f) Serve as a secretariat in following up on the activities of the proposed population and housing census working group for Arab countries that will be chaired by one country in the 2030 census round, and establish a small working group for countries implementing a combined census in the next three years, defining its tasks to coordinate joint regional action during the 2030 census round (and assist in the search for census funding for low-income countries, whenever possible);
- (g) Serve as a secretariat in following up on the activities of the statistical support working group for countries facing instability;
- (h) Support the reconstruction of post-conflict statistical systems and ensure business continuity and data flow within statistical systems in countries facing conflict and humanitarian crises.

II. Organization of work

A. Participants in the fifth meeting (Beirut and online, 7 and 8 March 2023)

7. The fifth meeting of the Technical Advisory Group on Demographic and Social Statistics in Arab countries was attended by 22 participants with practical and applied experience in demographic and social statistics in national statistical offices from the following countries: Bahrain, Egypt, Iraq, Jordan, Lebanon, Libya, Morocco, Oman, State of Palestine, Qatar, Saudi Arabia, Sudan, Syrian Arab Republic and Tunisia. The meeting was also attended by experts representing the World Health Organization, the International Labour Organization, the Regional Office for Arab States of the United Nations Population Fund, the Gulf Cooperation Council Statistical Centre, in addition to ESCWA experts. The list of participants is set out in the annex to the present report.

B. Participants in the sixth meeting (online, 3 and 4 July 2024)

8. The sixth meeting of the Technical Advisory Group on Demographic and Social Statistics in Arab countries was attended by 38 participants with practical and applied experience in demographic and social statistics in national statistical offices from the following countries: Algeria, Bahrain, Djibouti, Egypt, Iraq, Jordan, Kuwait, Lebanon, Libya, Mauritania, Morocco, Oman, State of Palestine, Qatar, Saudi Arabia, Somalia, Sudan, Syrian Arab Republic, Tunisia, United Arab Emirates and Yemen. The meeting was also attended by experts representing the League of Arab States, the Arab Institute for Training and Research in Statistics, the World Health Organization, the United Nations Children's Fund, the Gulf Cooperation Council Statistical Centre, in addition to ESCWA experts.
