October 23, 2002	The Tribunal is constituted. Its members are: L. Yves Fortier (Canadian), President; Aktham El Kholy (Egyptian); and Stephen M. Schwebel (U.S.).
December 20, 2002	The Tribunal holds its first session in Washington, D.C.
February 03, 2003	The Respondent files its memorial on jurisdiction.
March 03, 2003	The Claimant files its counter-memorial on jurisdiction.
March 31, 2003	The Respondent files a supplementary pleading on jurisdiction.
May 02, 2003	The Claimant files a supplementary pleading on jurisdiction.
May 07, 2003	The Tribunal holds a hearing on jurisdiction in London.
June 30, 2003	The parties file post-hearing briefs on jurisdiction.
March 12, 2004	The Tribunal holds a hearing on jurisdiction in Washington, D.C.
May 03, 2004	The parties file their post-hearing briefs.
July 07, 2004	The Tribunal renders its award.

Annulment Proceeding

Date	Development
November 12, 2004	The Secretary-General registers a request for the institution of annulment proceedings.
January 18, 2005	The <i>ad hoc</i> Committee is constituted. Its members are: Florentino P. Feliciano (Philippines), President; Omar Nabulsi (Jordanian); and Brigitte Stern (French).
May 19, 2005	The <i>ad hoc</i> Committee holds its first session in The Hague.
August 31, 2005	The Claimant files a memorial.
January 20, 2006	The Respondent files a counter-memorial.
March 30, 2006	The Claimant files a reply.
May 15, 2006	The Respondent files a rejoinder.
June 13, 2006 - June 14, 2006	The <i>ad hoc</i> Committee holds a hearing on the application for annulment in Washington, D.C.

July 21, 2006	The parties file post-hearing briefs.
July 28, 2006	The parties file submissions on costs.
March 20, 2007	The Claimant files a revised submissions on costs.
June 05, 2007	The <i>ad hoc</i> Committee issues a decision on the application for annulment of the award. The decision includes a separate opinion and a statement of dissent of one of the members of the ad hoc Committee.
