





Expert Group Meeting on the 2021 Situation Report on International Migration in the Arab Region Concept Note

I. Background

The Situation Report on International Migration in the Arab Region (SRIM) is a biennial report, which has since its first edition in 2015 provided an overview of key data, policy developments and major trends in the area of international migration and displacement in the Arab region. The thematic focus of the 2021 edition of the report is on resilient migrants, in a clear link to the COVID-19 pandemic in addition to other major crisis that have occurred in the region, which have had substantial fallout for the lives and livelihoods of migrants and refugees in the region.

The report is one of the key outputs of the Issue-based Coalition on Migration in the Arab Region (IBC), formerly known as the Working Group on International Migration in the Arab Region. The main purpose of the IBC is to coordinate the complementary efforts of international and regional actors in the Arab region related to migration and displacement, as well as to promote joint research and activities in this area. Today, the IBC brings together 23 participating organizations and is co-lead by the International Organization for Migration (IOM), United Nations Economic and Social Commission for Western Asia (ESCWA), the International Labour Organization and the League of Arab States (LAS).¹

II. Objectives of the publication

SRIM 2021 builds on previous editions of the report and works toward progressively building knowledge on international migration and displacement in the Arab region. The report provides a comprehensive and up-to-date overview of migration and displacement trends and patterns, a compendium of recent developments and new policies regarding the governance of migration and displacement in the region, and an analysis of migrant resilience in the Arab region. The main objectives of SRIM 2021 are to:

 Provide an update of the latest migration and displacement trends and patterns in the Arab region, with a focus on international migrant stocks based on the UN Population Division's International Migrant Stock 2020 database and on refugee data provided by UNHCR and

- UNRWA, complemented by other relevant data sources including: IOM, World Bank, ILO, UNESCO, UNICEF, IFAD and IDMC;
- Give an overview of developments in the governance of migration and displacement in the Arab region between April 2019 and December 2020, by thematic areas; and
- Provide a regional analysis of migrant resilience region in face of exogenous shocks such as
 the global health crisis caused by the COVID-19 pandemic. Moving beyond a singular lens
 approach focused on statistical analyses, the Report seeks to examine migrant experiences
 and challenges, illuminate how migrants are responding to the pandemic and highlight
 policies facilitating migrant resilience in the Arab region.

III. Meeting objectives

The Expert Group Meeting (EGM) aims to bring together the drafting and coordinating teams from ESCWA and IOM, focal points from the members of the Issue-based Coalition on Migration in the Arab Region (IBC), as well as experts in migration and displacement to review the draft of SRIM 2021. The draft of Chapters 1 and 2 with consolidated input received from IBC members and the first draft of Chapter 3 will be shared with the participants two weeks prior to the meeting, at the latest. The EGM will serve as an opportunity to discuss, provide input, and validate the research findings of the report.
