







UNRSF Project on "Reducing Road deaths and injuries in Jordan through increasing restraint use"

Third National Dialogue Workshop

On Awareness and Enforcement Campaigns for Road Safety Amman, Rotana Hotel, 16 March 2023

1. Background:

Within the framework of the UNRSF project, a first national workshop was held under the patronage of the Ministry of Interior on October 12, 2021 to discuss the project activities, the implementation plans, and to engage all related stakeholders to advice on the project's programs.

On September 15, 2022, a second national workshop was held under the patronage of the HE Minister of Interior; the workshop was dedicated to presenting a revised draft on seat belt and child restraint regulatory framework by the project experts, to improve road safety in Jordan by increasing the use of seat belts and child protection seats.

The third national workshop on March 16, 2023, under the patronage of His Excellency the Minister of Interior, will focus on the implementation of the remaining activities of the UNRSF project in Jordan. In particular, the seatbelt and child restraint awareness and enforcement campaigns with illustrations from the experiences of the developed countries in the road safety field, and the training of trainers course in collaboration with the Public Security Directorate.

The workshop's objective is to engage various traffic safety-related stakeholders and invite them to participate in a workshop to discuss the remaining activities and the appropriate implementation methods and plans, exchange the experience and the challenges between all parties to create common ground for the joint work. Furthermore, to advise the relevant stakeholders what is needed to successfully implement the project's remaining activities for the sake of raising the level of awareness on seat belt and child restraint at the national level and ultimately increase the restraining use and save lives. The workshop has main objectives:

- To present and discuss the progress of the project's activities and achievements.
- To present and discuss the proposed implementation methods of the remaining activities to ensure the achievement of the main goal of the project; to increase the rate of use of seat belts and child restraint by raising the level of awareness among the community and enforcing the laws.
- To present and discuss the proposed design of the awareness and enforcement campaigns with the concerned authorities in the Hashemite Kingdom of Jordan.
- To agree on a roadmap for the implementation of the awareness and enforcement











campaigns.

- To discuss and agree on how to implement the training of trainers course to prepare specialized trainers from the Public Security Directorate.
- Compile opinions and suggestions of the participants to agree on the most effective methods to develop a successful implementation plan.

Expected outcomes:

- Stakeholders feedback on the proposed design for awareness and enforcement campaigns.
- A draft roadmap for the implementation of the project's remaining activities, including awareness campaigns, enforcement and training of trainers courses, taking into account the stakeholders feedback.
