Background

This virtual event will mark the signature of a Letter of Understanding between the United Nations Economic and Social Commission for Western Asia (UN-ESCWA), the Ministry for Inclusion, Social Wellbeing and Voluntary Organisations (MIWV) in the Republic of Malta and the UN Special Rapporteur on the Rights of Persons with Disabilities to collaborate and give effect to the "EU-Arab Cooperation Forum on the Rights of Persons with Disabilities" which was established under the Valletta Political Declaration on EU-Arab Cooperation in Affirming Disability Rights in Valletta, Malta on 25 April 2019.

The "Cooperation Forum" will foster inter-regional cooperation to improve social inclusion of persons with disabilities in both the EU and Arab region. It will support collaborative efforts for capacity building, policy exchange, technical cooperation, and research, among others.

The first initiative under this cooperation shall be to establish the "Arab-EU Research Network on Disability". The network will foster inter-regional cooperation and knowledge exchange. It aims to support research, capacity building and curriculum development as a driver for change to improve social inclusion of persons with disabilities in both the EU and Arab region.

The work of the "Cooperation Forum" is aligned with UN's commitment to disability inclusion through the United Nations Disability Inclusion Strategy (UNDIS), which provides the foundation for sustainable and transformative progress on disability inclusion through all pillars of the work of the UN: peace and security, human rights, and development.
