Note by the secretariat

- 1. The secretariat of the Economic and Social Commission for Western Asia (ESCWA) has prepared the proposed organization of work for the fourteenth session of the Committee on Energy to facilitate the consideration of agenda items within time limits. - 4. Each presentation given by the ESCWA secretariat shall be limited to 10–15 minutes, to be followed by a discussion of about 30 minutes. Should the discussion of an agenda item be concluded ahead of schedule, the next agenda item will be introduced.
