14:00 – 17:00	Session V: Furthering National Development Efforts and Moving Forward: Needs and Ideas
	In the case of Yemen, the economic and social development is considered a key component in the process of state-building, and cannot be separated in any way from the political, institutional and legislative path. The failure of development, or the inability to formulate effective economic and social policies and to achieve the Yemenis' demand for justice, equality and decent living, would be sufficient to thwart any political or institutional reform plan. This session will examine these issues in light of the National Dialogue deliberations. Four speakers representing the governments, public sector, labor federation and civil society will present their thoughts on the themes.
