5th meeting of the Inter-Agency and Expert Group on Gender Statistics (IAEG-GS) in the Arab Countries

Provisional Agenda

The Statistics Division at the Economic and Social Commission for Western Asia (ESCWA) is pleased to convene two back-to-back meetings on Gender Statistics; the 5th meeting of the Inter-Agency and Expert Group on Gender Statistics (IAEG-GS) in the Arab Countries, from 15-16 October, and the Regional training workshop to improve use of existing data for monitoring gender equality and women's empowerment, from 17- 18 October, 2018 in Amman; the latter is implemented under the umbrella of the Tenth Development Account (DA10) Programme on Statistics and Data.

The Gender Statistics meetings brings together experts from the National Statistical Offices, Women Machineries, regional and international experts to review and discuss development of gender statistics for evidence-based policy making.

The IAEG-GS will discuss two main topics: (i) methods for compiling and calculating the Sustainable Development Goal 5 (SDG5) indicators, and (ii) the final version of the ESCWA Household Survey Questionnaire on Violence against Women presently being peer reviewed at the country level. Countries will share good practices in compiling and calculating SDG5 in the areas of their competencies. The expected outcome of the IAEG-GS will be the Arab Toolkit for SDG5, and ESCWA Household Survey Questionnaire on Violence against Women.

The Regional training workshop aims to improve technical capabilities in producing gender statistics to monitor SDG Tier I and II gender indicators and in disseminating, communicating and using statistics and indicators. ESCWA certified trainers from the countries attending ESCWA first Training of Trainers in the Dead Sea in 2016 will collaborate to present their localized modules of the Gender Statistics Toolkit, share their action plans and progress in rolling-out the national Programmes on Gender Statistics including progress made on the e-learning tool developed by ESCWA. The workshop will cover topics such as: integrating a gender perspective into official statistics; presenting, disseminating and communicating gender statistics; and improving gender statistics literacy among data users. The expected outcome of the workshop will assist countries in their efforts to mainstream gender into their national statistical systems, which will result in improved availability and use of gender statistics at the national, regional and international levels for better evidence-based gender policies.

In this context, NSOs are invited to participate through their senior gender statistical experts/ Training Team Leaders to make presentations towards the relevant sessions as per the latest gender statistics activities implemented in coordination and collaboration with the Statistics Division at ESCWA. In addition, ESCWA would appreciate the NSO to extend the invitation to a national counterpart collaborating to implement the Gender Statistics Toolkit Programme at the national level.

The key objectives of the workshop are:

- Strengthen national capacity in producing gender statistics
- Enhance monitoring and reporting on Tier I and II gender indicators
- Adopt international methods to measure SDG 5 indicators
- Exchange and share good practices and lessons learned on gender statistics training tools and implementation of the Gender Statistics Toolkit at national level
