## MAINSTREAMING

Landing SDGs into national, sub-national and local plans and shaping budgets, monitoring systems



## ACCELERATION

Targeting national & UN/UNDP resources at priority areas in response to bottlenecks, financing partnerships, etc.



## POLICY SUPPORT

Skills and expertise of UN/UNDP system



**PARTNERSHIP DEVELOPMENT:** channel additional support for partnership development activities, including for parliaments, CSO, private sector, media

**ACCOUNTABILITY:** establishing monitoring and review frameworks

**DATA:** contributing to data revolution by strengthening national capacities to collect and analyze information to monitor progress on 2030 Agenda and SDGs

# Localizing the SDGs



**Mainstreaming SDGs at Sub-National and Local Level - Key Steps**

- 1 Strengthening political commitment for the SDGs (local governments, councils, MPs)
- 2 Clarifying central/local responsibilities (for SDG prioritizing, finance, impl., M&E)
- 3 Defining sub-national/local priorities and indicators (building on unfinished business of MDGs')
- 4 Integrating SDGs in sub-national/local development plans & budgets (incl. 'Whole of local government approach')
- 5 Mapping local financing opportunities and improving local fiscal administration (incl. anti-corruption)
- 6 Building partnerships and social monitoring (CSOs, private sector, etc)
- 7 Etc.

# Identifying and Investing in Progress Accelerators

Not all SDG goals and targets can be pursued equally and at the same time



- Identifying and investing in ‘accelerators’ – intervention areas that can yield multiple dividends across various Goals and Targets
- Identifying implementation bottlenecks
- Managing risks – Building in resilience
- Adapting innovative acceleration solutions across countries



*(under development)*

- Acceleration toolkit (multi-sectoral solutions)
- Simplified modeling tools
- Accelerator identification/Bottleneck analysis - **building upon the MDG Acceleration Framework**
- Risk Management Guidelines
- Poverty Risk Analysis Tool

**Mainstreaming the SDGs in plans is an essential key step, but making substantive progress towards SDG targets will be the key challenge**
