Meaningful access for inclusion and diversity

Internet access needs to be meaningful and inclusive to enable potential development benefits; and while the deployment of digital and broadband technologies increases, the impact varies from country to country and the digital divides continue to increase in number and grow in depth. Digital transformation and digital economy

The session covers the topics of digital transformation and digital economy that have become key areas in addressing the economic development methods and models in light of the amazing technological advancements and the multitude of available applications and their economic and social impacts. - 6- How can the ArabIGF process contribute to promoting the digital economy in the Arab region and what is the role of various stakeholders in digital transformation?
- 7- How can the open dialogue impact digital transformation in the region and what are the challenges facing the adoption of digital strategies?

Cyber security, privacy, trust and peace

The issue of cyberspace security has many implications for trust within the digital environment, which has become an international facility and at the same time exposed to threats by actors from various countries and other threats by non-state actors. This increases the importance of addressing these threats in order to improve response patterns, especially with the escalation of the violation of privacy and the threat of militarization of cyberspace. This requires an Arab effort through the forum to cooperate with international efforts in order to support the peaceful use of cyberspace and try to complement the previous efforts of the forum with the outcomes of the Global Internet Governance Forum in Berlin, Germany. Thus, appropriate policies need to be developed and consensus built to try to formulate an Arab vision that expresses priorities and interests of the region in order to enhance opportunities for development and peacebuilding in conflict areas through cyberspace, while encouraging a culture of tolerance for coexistence. The challengers will try to answer the following questions:

- What are the emerging challenges related to Internet resource infrastructure?
- O What is the impact of 5G and Internet of Things services on security and trust?
- o How does the Arab region benefit from international efforts to protect personal data?
- O What future is held for extremist rhetoric on social media?
- How do countries face cyber wars and cyber-attacks?

- o What is the effect of militarization of artificial intelligence and how to meet the challenge?
- Where is the Internet going, to open space or fragmentation?
- What is the impact of the escalation of allegations of digital sovereignty of countries in the trends of Internet governance?
- What effect does this have on cyber norms applications in cyberspace?
- O How can we impose cyber peace in the digital age and what are its challenges?
- What is the role of national strategies for cybersecurity in facing challenges and what are the frameworks for cooperation with relevant international organizations such as the ITU?
