

UNFPA authorized recently the holding of a similar meeting under a population programme (P.F.2.1 output iv, a seminar on international migration with special emphasis on the Arab world) (duplication of activities).</p> <p>The programme element was terminated due to: (i) difficulties in obtaining data on this sensitive subject, (ii) programme element requiring a relatively large amount of resources and (iii) identification of programme elements of higher priority within the programme (activity of marginal usefulness and of low priority in relation to resources).</p>

a/ These resources were redeployed within the programme under the remaining outputs 1.1 (i) and 1.2 (iii) which have been reformulated. This proposal as well as all the other proposals referred to in the foot-notes (b) to (g) will be reported to the Economic Commission for Western Asia at its eighth session to be held in April 1981.

b/ These resources remain in the same programme element and will be used for the preparation of papers on regional development strategy for the Third Development Decade.

c/ In practice, no release of the resources can be expected as the post is vacant. If recruitment were made to fill in the post in the course of the biennium, whatever resources available would be redeployed to programme elements 1.2 and 1.4 within the same programme.

d/ These resources were redeployed to programme elements 1.1 and 1.2 within the programme.

e/ Resources will remain in the same programme element and will be used for the preparation of studies and reports to be submitted to related meetings under population programme, programme element 2.1 (iv).

f/ During the current work programme (1980-1981) these resources will be redeployed within the programme among the remaining programme elements 2.2, 2.3 and 2.4. However, for the 1982-1983 biennium they will be proposed for redeployment to science and technology programme.

g/ These resources were redeployed within the subprogramme to programme elements 1.1 and 1.2.
