Population and Development in the Arab Region: Challenges and Prospects Ten Years After the 2013 Cairo Declaration

Online, 11 May 2023

I. Background

The 1994 International Conference on Population and Development (ICPD) represented a remarkable consensus among 179 Governments that human rights and dignity are necessary preconditions for sustainable development. The ICPD Programme of Action (PoA) reinforced linkages between population, development and the environment, and shifted international discourse on population and development from a focus on reaching specific demographic targets towards a greater emphasis on people's wellbeing and their individual rights and choices.

The PoA identified a set of objectives and goals covering a plethora of issues in the context of sustainable development, including population, sustained economic growth and poverty; education, gender equality, equity and empowerment of women; sexual and reproductive health and reproductive rights; mortality and morbidity; population distribution, urbanization and migration. It also addressed the specific needs and challenges of various population groups in light of emerging demographic trends, environmental changes and other social and economic developments.

The ICPD reviews undertaken over the span of 25 years affirmed that the goals are still legitimate despite the significant progress made globally on several fronts. In the Arab Region, the reviews of the PoA revealed impressive declines in infant, child and maternal death rates; improved reproductive health care and family planning services; increasing school enrolment ratios; improved gender parity in education; and improved access to safe water, among other goals. At the same time, the regional reviews also documented that progress has been partial and uneven among and within countries, and shortfalls remain in key areas such youth development, quality of education, empowerment of women and girls, rural development and persistent gender-based violence. In addition, new challenges and realities emerged such as shifts in demographic structure, increased migration and urbanization, climate change and rising inequalities. The fourth review of the ICPD in the Arab region, resulted in the adoption of the 2013 Cairo Declaration, an intergovernmentally negotiated roadmap for achieving the ICPD objectives in the Arab region.

II. The Sixth Regional Review Process of ICPD

Against this backdrop, ESCWA, UNFPA Arab States Regional Office (UNFPA-ASRO) and LAS, are co-leading its ten-year review of the 2013 Cairo Declaration, as part of the review and appraisal of the ICPD PoA 30-years after its adoption.

To ensure a systematic and effective process, the review is composed of several stages:

- In October 2022, Member States nominated national focal points that were invited to lead the coordination and preparation of the voluntary national review reports.
- To support Member States representatives with developing the national reports, ESCWA, UNFPA and LAS prepared a guiding template in line with the structure and narrative of Cairo Declaration 2013.
- ESCWA, UNFPA and LAS also organized two capacity building workshops: the first one discussed
 the modality of the review process and agreed on the guiding template. The second workshop
 reviewed the progress made by countries in collecting the information needed for the reports.
 The findings from the voluntary review reports will be synthesized in a regional review report and
 will be presented in the Regional Review Conference.
- The review process also includes a series of consultative dialogues with various constituencies including parliamentarians, and non-governmental stakeholders in May 2023 to ensure their optimal engagement in the review process.
- Finally, the regional review process will culminate in a Regional Review Conference that will be held in a hybrid format in Beirut, on 19-20 September 2023.

III. Parliamentary Dialogue on the Sixth Review of the International Conference on Population and Development in the Arab Region: Challenges and Prospects Ten Years after the 2013 Cairo Declaration

The ICPD PoA (1994) acknowledges the positive role of parliamentarians in shaping public opinion and public policy and urges them to be actively involved in increasing awareness of population and development issues and to take the required actions to monitor and appraise progress towards meeting the goals of the ICPD PoA, in accordance with national priorities. In addition, it calls for regular exchanges of experiences among parliamentarians at the subregional, regional, interregional and international levels, where appropriate to ensure its effective implementation.

Similarly, the 2013 Cairo Declaration calls for engaging all relevant stakeholders, including policy-makers, parliamentarians, educators, health care providers, the private sector and the media, in creating an environment conducive for the implementation of the Declaration and to the enjoyment of rights by all population groups.

A. Objective of the parliamentary dialogue

The dialogue aims at bringing together parliamentarians from the Arab region to:

- a. Provide an overview of the ICPD regional review process at regional and national levels, present key demographic trends and patterns in the Arab region, and discuss common trends, challenges and gaps in implementing the 2013 Cairo Declaration.
- b. Facilitate the exchange of knowledge and expertise on the engagement of the parliamentarians and their contributions to population and development issues, and in monitoring the implementation of the Cairo Declaration at national and regional levels.
- c. Raise awareness and build on earlier commitments made at relevant parliamentarians' forums, including the parliamentarians' meeting to follow—up on ICPD@25 commitments.
- d. Discuss challenges faced and means to optimize the engagement of parliamentarians with population issues as well as in integrating population matters in national policy making processes, with a view to accelerate the implementation of the 2013 Cairo Declaration.

B. Participants

The dialogue will bring together parliamentarians from Arab countries concerned with social and population issues, including members of Committees on lawmaking, social affairs, education, health, human rights, and budget.

C. Date and venue

The dialogue will be held virtually on 11 May 2023, in **Arabic,** from 10:00 am to 13:00 pm Beirut time as per the proposed organization of work below. The link to the meeting will be provided to the confirmed participants ahead of time.

D. Expected outcomes

- a. Increased knowledge among parliamentarians on the regional review process of the 2013 Cairo Declaration.
- b. An outcome document that summarizes key messages and recommendations to optimize Arab parliaments' engagement in the implementation of the 2013 Cairo Declaration. The document will feed into the regional review Conference to be held in September 2023.
