Summary

The present document sets out the technical cooperation activities undertaken by the Economic and Social Commission for Western Asia (ESCWA) in the field of statistics from January 2017 to December 2018, including advisory services, workshops, fellowship programmes and capacity-building activities

The Statistical Committee is invited to take note of the present document and provide proposals on strengthening technical cooperation services in line with the needs and priorities of member States.

Introduction

1. Technical cooperation activities by the Economic and Social Commission for Western Asia (ESCWA) are designed to meet the needs of member States, and are generally provided on demand. In addition to the flexibility of the Regular Programme for Technical Cooperation (RPTC) in tackling emerging and urgent issues, it has recently succeeded in shifting towards a results-oriented work strategy, based on developing comprehensive national frameworks for coordinated cooperation. The ESCWA secretariat aims to use those frameworks as an integrated planning tool to increase the effectiveness of technical cooperation and strengthen transparency and accountability in activity implementation. ESCWA considers technical cooperation activities a priority, alongside data collection, production and dissemination; coordination; and forging regional partnerships.

2. ESCWA work in the field of statistics aims to support national and regional statistical systems in producing and disseminating quality statistics to formulate evidence-based policies and monitor progress towards inclusive and sustainable development. Most technical cooperation activities are implemented in coordination with the regional offices of specialized United Nations organizations and other regional and international organizations. The present document summarizes the technical cooperation activities undertaken by the secretariat from January 2017 to December 2018, and addresses the challenges faced in the implementation of technical cooperation programmes and services, and ways to improve on them.

I. ADVISORY SERVICES

3. Table 1 sets out advisory services provided by the secretariat from January 2017 to December 2018, listed by recipient and type of activity. Those services aimed to build member States' capacity to adopt the System of National Accounts (SNA) as a general and comprehensive framework. The adoption of a unified system allows for the integration of various economic statistics in a single framework, such as supply and use tables, so as to achieve integration between various economic statistics, notably national accounts statistics, affiliated accounts, trade and business statistics, statistics for various economic sectors, and estimates related to the informal economy.

4. The ESCWA secretariat also supports member States in developing the required statistical infrastructure, mainly international classifications, information and communications technology, and statistical business registers. The secretariat organized workshops and advisory missions to that end.

III. CHALLENGES AND THE WAY FORWARD

6. The Arab region continues to witness transformations and economic and social crises, which pose challenges that have redefined priorities in the field of statistics. Meeting countries' needs for data and information requires innovative measures, increased activities at the national level, and further advisory missions in the field of social, demographic and economic statistics.

7. It is vital to strengthen regional cooperation with regional statistical agencies, such as the Arab Institute for Training and Research in Statistics, the Statistical Centre for the Cooperation Council for the Arab States of the Gulf (GCC-Stat), the Statistical, Economic and Social Research and Training Centre for Islamic Countries, and the Arab Monetary Fund. Those agencies are not part of Regional Coordination Mechanism that includes United Nations organizations working in the Arab region, but play a key role in the field of statistical Committee, which can provide a platform for dialogue on regional priorities in the field of statistics, and thus increase coordination of technical cooperation activities.

8. The secretariat aims to support national statistical offices in their work to monitor progress towards achieving the 2030 Agenda and to prepare reports in that regard. It will also increase understanding of key developments in data collection, processing, updating and dissemination, especially using modern technologies.

9. The Statistical Committee is invited to provide proposals on operationalizing technical cooperation services, in line with member States' needs and priorities.
