I am so grateful to my colleagues of ESCWA for working with DESA always as one team and one UN and - last but not least - for co-organizing this important event today for wider dissemination of the core finding of the Survey in the Arabic Region.

And talking about dissemination in the region, I would also extend my deepest appreciation and special thanks to the Telecommunication Regulatory Authority of United Arab Emirates, in translating the Survey into Arabic.

So, today I am so proud to announce that, thanks to UAE and ESCWA, the Arabic version of the 2020 E-Government Survey is now available on our portal and on ESCWA website, ready to be downloaded.

I am sure that the Arabic version of the report will reach a wider range of Arab-speaking audiences and will help policy-makers in the region to utilize its findings for further development on digital transformation.

In the next session, I will sharing some key findings from the 2020 survey on global and regional trends in e-government development –to set the scene for a fruitful discussion on the opportunities and challenges of digital transformation.
