# SDG13: Advancing Climate Action in the Arab Region

# Tuesday 9 April 2019, 16:15-18:00, MZ Meeting Room, UN House, Beirut

## Background

SDG13 calls on the global community to take urgent action to combat climate change and its impacts and is one of the six SDGs under review during the 2019 HLPF. Examination of SDG13 requires consideration of SDG8 (particularly on decoupling economic growth from environmental pollution, which can be supported through the transfer of appropriate technologies and finance); SDG 10 (particularly on reducing inequity within and across countries in terms of vulnerability to climate change impacts and the ability to access the means of implementation needed to pursue climate action); and SDG16 (in light of supporting climate action through effective and accountable institutions that can enhance the resilience of developing states and vulnerable communities at the regional, national and sub-national levels). SDG13 also seeks enhanced preparedness for natural disasters, which necessitates capacity building and education (SDG4). Accessing means of implementation (SDG17) in light of these goals will be the focus of the special session.

# **Session Objective**

Following an overview of regional priority issues and concerns related to climate change, it is expected that the panel will focus on solutions and ways to better engage and respond to the concerns of women, youth and vulnerable group in pursuing climate action. The panels will include discussions on climate change vulnerabilities, risks, and impacts; awareness raising; and means and modalities for enhancing resilience and climate planning and action, with focus on means of implementation including finance, technology, and capacity building.
